AUDRUVIS CHAMPIONS TOUR 2022 GENERAL INFO

QUALIFICATION CLASSES AND HEIGHTS:

BRONZE TOUR	100cm – 105cm
SILVER TOUR	110cm – 115cm
GOLD TOUR	120cm – 125cm
DIAMOND TOUR	130cm - 140cm

QUALIFICATION POINTS:

Qualification points are counted as follows: I st place 30 points +1 // IInd place 30 points -1 // IIIrd place 30 points -2 and etc.

For example: First place will get 31 points, second place will get 29 points, third place will get 28 points and etc..

FINAL

Everyone can participate in the final. But points are counted only for riders who have competed in Ist or IInd stage. IIIrd day of the final riders compete in reverse order depending on collected number of qualification points (rider who have the highest number of points is jumping as last number in the class). In case rider have two horses in the same class there must be 15 horse-rider combinations space in the start list.

Coefficient principle of qualification points in the final:

- Bronze/Silver/Gold/Diamond Tour final Ist and IInd day qualification points coefficient is 1.

- Bronze/Silver/Gold/Diamond Tour final IIIrd day qualification points coefficient is 2.

Final results of Champions Tour depends on collected points after two stages and final. In case of the same number of qualifiation points for two riders - final result depends on the result of final the class!

On the final podium are invited Champions $(1^{st}/2^{nd}/3^{rd} \text{ places})$ of each tour and awarded as follows:

- Bronze Tour sponsor prizes
- Silver Tour sponsor prizes
- Gold Tour Champion 500 EUR / Vice Champion 300 EUR / 3rd place 150 EUR + sponsor prizes
- Diamond Tour Champion 1000 EUR / Vice Champion 600 EUR / 3rd place 300 EUR + sponsor prizes

GENERAL RULES

- One horse can have 2 starts per day.
- If a rider has three or more horses in the same tour class he must to write in entry form NOTES which two horses he choose to collect qualification points.
- It is allowed to collect qualification points with the same horse in different tours.
- It is allowed to collect qualification points for different riders with the same horse.





- Jumping without record is allowed in two cases - if rider leaves arena then he is allowed to jump only after all competitors in the end of the class or if the rider stays in arena then he is allowed to jump after next competitor.






IX. VETERINARY MATTERS

GENERAL

In accordance with the FEI Code of Conduct for the Welfare of the Horse it is imperative that all Horses are physically fit and free from infectious disease before being allowed to compete.



PASSPORTS AND LICENSES

All horses competing in competitions must have a valid passport (National or FEI Passport / FEI Recognition card). Lithuanian riders and their horses must be registered with Lithuanian Equestrian Federation and have valid licenses to participate in the event.

VACCINATIONS AND BLOOD TEST

Flu vaccination should be valid in accordance with Lithuanian veterinarian requirements (according to manufacturer requirements, once a year). Blood test according Lithuanian State food and veterinary Service requirements, horse blood should be tested against 3 diseases (Equine infectious anaemia, Dourine, Glanders) once per year.

X. ADDITIONAL INFORMATION

1. RESPONSIBILITY

Equestrian sports involve inherent dangerous risks. To the greatest extent permitted by law, Organiser shall NOT be liable for any damages relating to loss of property, sickness including but not limited to COVID-19 or injury of any kind to Athletes, Owners, Support Personnel or Horses at or in connection with the Event. Damage to horses, coaches, saddles, stable attachment and other property (including stealing and loss) will not fall under responsibility of the Organiser. We recommend that the insurance would be sought individually.

2. INSURANCE

It is your responsibility as an Athlete/Owner/Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at Event and in particular to insure





against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a show.

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to Events at home and abroad, and to keep the policy up to date. The Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

3. BEHAVIOUR DURING COMPETITION

The Organizer will not accept sales or offers to sell hay, shavings and straw by any other suppliers in the show ground during the show. For any illegal sales, a fine of 100 EUR per offence will be charged. Repeating offence at the Event may lead to exclusion from the Venue. Motors, guads etc. are not allowed in the stable and competition areas.

If allowed at the Event, all dogs must be leashed and affixed to a human or stationary object. Violation of this rule will incur a fine of 80 EUR per offence and, in case of a repeated offence at the Event, may lead to exclusion from the Venue.

4. PROTECTION OF PERSONAL DATA

PHOTOS AND VIDEOS

By making an entry to the Event Athlete consents to being photographed and/or video recorded by the official Photo/Video team of the Event. Photographs and/or video recordings including images of Athlete, can be used both internally and externally to promote the Event. These images could be used in print and digital media formats including but not limited to print publications, websites, emarketing, posters, banners, advertising and social media purposes.

PERSONAL INFORMATION

The company responsible for maintaining entries website Zawodykonne.com is as well responsible for the storage and protection of data. Startlists and Results at Zawodykonne.com will include same information as requested on the entry. However, age of the Athlete, contact details, address and company details will be excluded. During the Event official Announcer will use First Name and Last Name of Athlete, Horse details including first and last name of the Owner, results and rankings well as previous accomplishments in Equestrian Sports. You have right to disagree to provide personal information requested in the Schedule. However, if you disagree to provide requested information the Entry will be declined.
